When is an application for driveway levels required?
Before constructing a driveway an application form must be completed to attain a permit to undertake construction. This application excludes the construction of retaining walls, stairs and other substantial structures, for these please refer to the Infrastructure Works on Council Roadway (if associated with a development application) or the <i>Application for a Minor Encroachment on a Road Reserve form</i> (if not associated with a development application).
About this application form
The construction of a driveway must be undertaken by an Authorised Contractor. A list of contractors authorised by Council is available at northernbeaches.nsw.gov.au If your preferred contractor is not on this list please note that they must become authorised prior to carrying out work. This may delay the processing of your application by approximately 6 weeks. The contractor is required to complete Form #4026 to be assessed for authorisation.

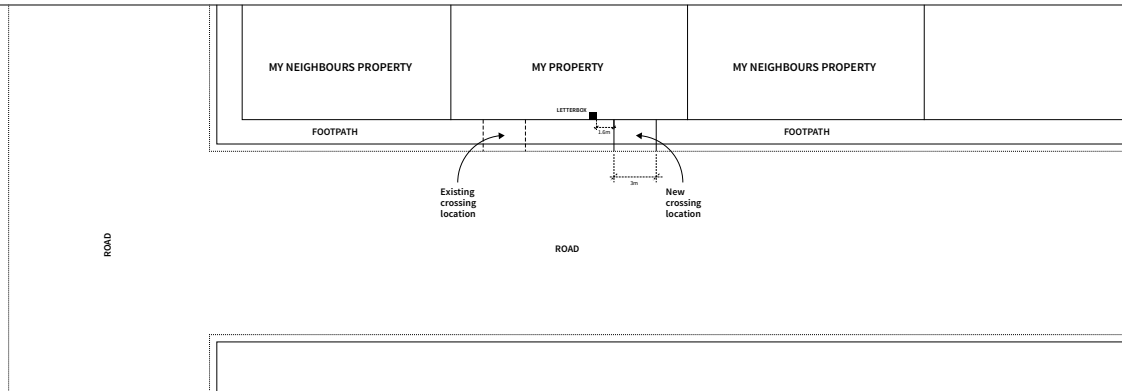

Construction of any kind (including excavation) must be carried out by contractors authorised by Council. The standard residential driveway crossing width is 3 metres. Note that under exceptional circumstances no more than one vehicular access is permitted per dwelling.

Width of driveway crossing
Driveway finish shall be constructed with plain broom finished concrete, or approved equivalent. All cosmetic/decorative treatments, including but not limited to, asphalt, paved, coloured, exposed aggregate, stamped, stencilled and post construction treatments are not authorised. Failure to comply with this requirement may result in demolition of the crossing and reconstruction of the crossing to Council standard, with all costs borne by the applicant. Fees apply for assessment of driveways constructed not in accordance with Council specifications.
