TERMS AND CONDITIONS OF USE

All conditions have been established to ensure maximum enjoyment and usage of the Centre have the usage rights and obligation as detailed below.

- Membership Fees & Access (see back for prices)
 - Pay as you go** (casual) participants entry is only **valid on the day of purchase or day of booked class/session**.
 - 10 visits passes** is only **valid for three years only, from the date of purchase**.
 - Direct Debit Members** fees are paid via **fortnightly debit from a selected account** dependent of the number of session you book.
- A member must present their membership card for admittance to the Centre. Admittance may be refused if a member fails to provide their card on request of Centre staff.
- You can attend any of the timetabled classes in line with your ability. Your instructor/coach will let you know if you need to start attending a different level of class/session. Please arrive at least 10 minutes prior to the class time.
 - Pay as you go & visit pass** participants can attend on a flexible schedule and not locked to a particular session/s.
 - Direct debit members** are booked into your chosen sessions and guaranteed a place. Sessions can be moved/changed but we recommend you to stick with certain sessions. You are eligible for 9 notifications (reschedules or family practice passes) and 30 days suspension per calendar year. Notifications must be emailed at least 30 minutes prior to session and Suspension request require 14 days emailed written notice. Cancellation requires 30 days notice via the Cancellation request form which can be submitted online or over the desk in the centre. Emails are not accepted as notice of cancellation.
 - The Adult Water Awareness program** is run for a consecutive 5 weeks and you are unable to make up or change any missed session from the program blocked you are booked for. Any missed session will be forfeited. Other alternatives may be available at discretion of swim school management.
- A Card replacement fee will be charged to replace lost /damaged or stolen cards.
- Multi Visit Passes may be lent or transferred to another person. However, the Adult Program Agreement form is to be completed by any persons participating.
- Before a member may enter the Centre they shall first have swiped their pass through the reader (and accepted as valid) and shall, if required by the any employee of the Centre, produce their pass to the employee for verification and furnish all reasonable information regarding the same. Any pass holder failing to produce their pass when seeking admission to the Centre may be required to pay the prescribed admission fee.
- The Centre reserves the right to cancel this membership agreement and request return of membership cards at its discretion.
- The Centre reserves the right to vary, add or eliminate from time to time the opening hours or scheduled hours of any of the particular facilities, classes or services.
- All participants agree to comply with all Centre rules. Members must not carry out any illegal acts in the facility and must comply with all our health and safety requirements. If a Member carries out any activity, which we consider offensive or dangerous to you or another person, we reserve the right to ask you to leave immediately and this may also result in cancellation of membership.
- Manly Andrew Boy Charlton Aquatic Centre respects your privacy. Our purpose in collecting personal information from you is to help us provide you with better service. We will not wilfully or deliberately disclose any individually identifiable information about you to any third party without first receiving your permission.
- I agree and accept that a particular facility or service may not be available for participation due to a prior booking, mechanical breakdown, fire, act of God or any other reason. I agree not to hold the Centre responsible for such an occurrence.

Direct Debit Missed Session Options

Students are eligible for the following options for missed lessons per calendar year;

Suspensions;

- 4 weeks per calendar year
- 2 Weeks written notice via email is required to be eligible for this option.
- \$1 per day rather than your normal fee (max charge per week is \$6)

Notifications;

- 6 per calendar year
- Notice MUST be given via email at least 30 minutes prior to your session
- Normal session charge applies (No additional costs are allocated)
- You will receive a family practice pass in lieu of your missed lesson. The pass allows entry for up to 5 people into the pool (maximum of 2 adults)

There are 2 options to utilise your notification. These are;

Rescheduled Session – You **must** email swimschool@manlyaquatic.com.au to book into the additional session at least 24 hours in advance to allow the swimmer access to the changed session and must be used prior to the last session in the current year. Any notifications of sessions strictly cannot be rolled over to any of next year's sessions.

Family Swim Pass – The session can be used as Family Swim Passes which allows entry for up to 2 adults and 3 children or 1 adult and 4 children to the pool. Family practice passes strictly expire on the 31st of December and cannot be extended past this date.

NOTE:

All Family practice passes expire on the 31st of December each year. Under no circumstances are these extended past expiration date.
All missed lesson options re-set at the end of each year. Unused suspension weeks or Notifications do not roll over to the next year.

Direct Debit Payment & Cancellation Terms

Payment of Fees

Memberships are debited fortnightly in advance from your selected bank account and will show on your statement as Northern Beaches Council, there is a 7-day cooling off period from your first session. There is no refund for any monies paid in advance. Fees will increase each financial year in line with councils adopted fees and charges. All dishonored payments will incur a \$2.50 penalty fee. More than 3 outstanding payments will result in cancellation of lessons. Any outstanding fees must be paid in full prior to re-joining the program.

Cancellations

Minimum of 30 days' notice is required to cease lessons. Notification is required in writing via the cancellation form. The form must be completed in the Centre or via the online request form. Emails will not be accepted for cancellations, nor will cancellation requests be backdated to the date of an email sent regarding cancellation. No refund will be given for any monies paid in advance unless a medical certificate or proof of relocation is provided (needs to be more than 25kms from the Centre to qualify). During the cancellation period you are not eligible for any missed lesson options unless a medical certificate, travel documents or relocation documents are provided.
