Dear Councillors

I wish to provide further clarification on the locations proposed to be signposted as Alcohol Prohibited Areas on Australia Day 26 January 2021. All ocean beaches and adjoining reserves plus the following estuary reserves will be signposted:

- East and West Esplanade, Manly
- Fairlight Beach, Manly
- Little Manly Reserve and Point, Manly
- Narrabeen Lagoon Foreshores, Narrabeen and North Narrabeen
- Clareville Beach, Clareville
- Winnererremy Bay, Mona Vale
- Church Point Reserve, Church Point
- McCarrs Creek Reserve, Church Point
- Governor Phillip Park, Palm Beach

*Dear Mr Lawler*

*Further to my correspondence dated 27 November 2020, I wish to provide the following clarification on NSW Police Force request for Council to declare Alcohol Prohibited Areas from 6am on 26 January 2021 to 6am on 27 January 2021.*

*I request that signage be erected at all ocean beaches and adjoining reserves. Also, I would like signage installed at the following estuary beaches and adjoining reserves:*

- *Clontarf reserve Clontarf*
- *Forty Baskets Reserve, Balgowlah*
- *East and West Esplanade Manly*
- *Fairlight Beach, Manly*
- *Little Manly Reserve and Point, Manly*
- *Narrabeen Lagoon Foreshores*
- *Clareville Beach, Clareville*
- *Winnererremy Bay Mona Vale*
- *Church Point Reserve, Church Point*
- *McCarrs Creek Reserve, Church Point*
- *Governor Phillip Park, Palm Beach*

*The erection of signage assists NSW Police Force in ensuring compliance.*

*Notwithstanding this, as all beaches and reserves are temporary Alcohol Prohibited Areas, NSW Police Force still has the power to ensure compliance without the need for signage.*
