<p>Council will conduct a preliminary assessment of the application. If the preliminary assessment is considered satisfactory, the application will be referred to Council's independent Consultant (BNG Conserve) who will handle the accreditation process. BNG Conserve will assess the application against the following assessment criteria:</p> <ol style="list-style-type: none"> <li>1. Incorporated company/ business name and ABN</li> <li>2. Public Liability Insurance</li> <li>3. Workers Compensation Insurance</li> <li>4. Accident/ Injury Insurance Cover – sole traders only</li> <li>5. Vehicle, plant and machinery insurance</li> <li>6. Company licences, registrations, permits, certificates etc.</li> <li>7. WorkCover Construction Industry General Induction Card</li> <li>8. WHS documents</li> <li>9. Employee qualifications – certificates, licences etc.</li> <li>10. WHSMS Self Evaluation</li> </ol> <p><b>All correspondence regarding the accreditation process is between the applicant and BNG Conserve.
