| <b>Electronic Lodgement Instructions &amp; Disclaimer</b> | <p>All applications must be lodged through the NSW Department of Planning, Industry &amp; Environment's Planning Portal. For steps outlining how to lodge your Development Application, please refer to Council's 'Lodge your Application' web page.</p> <p>To allow Council to process your application in a timely and efficient manner, please ensure documents are lodged in accordance with the following:</p> <ol style="list-style-type: none"> <li>1. Mandatory documentation is lodged as outlined on page 1.</li> <li>2. A master set of plans as outlined on page 1 are to be uploaded as <b>one</b> file in the Planning Portal (Document Type 'Architectural Plans'). Note: Landscape and stormwater plans are to be uploaded as separate files in the portal.</li> <li>3. Reports are uploaded separately.</li> <li>4. Documents are to be titled in the below naming format examples: <ul style="list-style-type: none"> <li>• Owners Consent</li> <li>• Cost Summary Report Form</li> <li>• Plans – Master Set</li> <li>• Plans – Landscape</li> <li>• Plans – Stormwater</li> <li>• Report – Geotechnical</li> <li>• Report – Bushfire</li> <li>• Report – Statement of Environmental Effects</li> <li>• Statement of Modification</li> </ul> </li> </ol> <p><b>Disclaimer – Documents on Public Exhibition</b></p> <p>By lodging a Development Application you acknowledge and agree to the use of all relevant plans and reports lodged with the application for public exhibition purposes and note that they will be made available to the public on Council's Application Search.</p> <p><b>Note:</b> It is not the responsibility of Council to remove signatures or owner's details from documentation lodged, this is the responsibility of the applicant prior to lodgement of the application</p> |
| <b>Modification Application Requirements</b>              | <p>Your modification application must clearly explain the amendments that you wish to make. If the amendments involve changes to the design, the application must include copies of plans that show these changes plus all relevant supporting documentation that justify the change/s.</p> <ul style="list-style-type: none"> <li>• A Statement of Modification must be submitted with all modification applications that describes in detail all the proposed modifications that form part of the application and discusses any impacts these changes have on the relevant planning controls and on adjoining or nearby properties.</li> <li>• Plans indicating all proposed modifications to the approved development. The modifications must be clearly highlighted and should be in colour. Every plan from the original development consent that needs to be modified by the Modification Application must be provided.</li> <li>• Reports – If the original development application is supported by reports (i.e. Bushfire, Geotechnical, Flood Risk Assessment, Statement of Heritage Impact, etc) the reports must be updated so that they are relevant to the development as modified. Alternatively, a letter may be provided from the original author of the report/s stating that the recommendations of the original report, are still current for the proposed modification.</li> <li>• BASIX Certificate – An amended BASIX Certificate is required if the original application included one.</li> </ul>   |
| <b>Owners Consent</b>                                     | <p>Applicants are required to enter the details of <b>all</b> individual land owners' onto the Planning Portal. The property title document or a current rates notice will provide this information.</p> <p>Where a landowner is one of the following, the relevant supporting documentation must be uploaded into the Planning Portal as Owners Consent:</p> <p><b>Company / Organisation</b><br/>Applicant must provide an <a href="#">ASIC Current Company Extract document</a>. Where there is more than one company owner, council may request additional supporting documentation. Document must list office holders.</p> <p><b>Land/New Owners(s)</b><br/>Applicant must provide a copy of the Notice of Sale or Settlement Letter.</p> <p><b>Strata Title / Owner's Corporation (if the property is a unit under strata title or a lot in a community title)</b><br/>Applicant must provide a letter on strata management letterhead, clearly stating the words "Support for lodgement of Development Application".</p> <p><b>Joint Wall / Fence</b><br/>When works affect a joint wall, consent of all affected property owners is required (e.g. Semi-detached dwelling). The title document or a current rates notice of each property will provide this information.</p> <p>Note: Council may request additional supporting information depending on the nature of the development proposal.</p>   |
| <b>Statement of Environmental Effects</b>                 | <p>A Statement of Environmental Effects must be submitted with all applications, and is to;</p> <ul style="list-style-type: none"> <li>• describe the site in detail (current use, aspect, slope, vegetation etc.),</li> <li>• describe the proposed development in detail,</li> <li>• demonstrate that the environmental impacts of the development have been considered,</li> <li>• respond to all relevant provisions of any applicable environmental planning instruments (SEPPs), development control plans and Council policies,</li> <li>• include a compliance table showing the performance of the development against the relevant numerical standards and controls,</li> <li>• provide justification for any areas of non-compliance with relevant objectives, standards or controls,</li> <li>• discuss any likely impacts and identify any mitigation measures to reduce those impacts.</li> </ul> <p>Additional details may be required for certain development, including:</p> <ul style="list-style-type: none"> <li>• hours of operation, trading hours and/or delivery times,</li> <li>• staff numbers,</li> <li>• plant and machinery to be installed, including hours of plant operation,</li> <li>• type, size and quantity of goods to be made, stored or transported.</li> </ul> <p>If the application seeks to vary a development standard within an Environmental Planning Instrument, a <b>separate</b> document is required (see below).</p>  |

| <b>Cost Summary Report/Quantity Surveyors Report with Estimated Cost of Works</b> | <p>Council's Cost Summary Report Form must be submitted with all applications as follows:</p> <ul style="list-style-type: none"> <li>• Development with an estimated cost up to \$1,000,000 – Cost Summary Report Form completed by a Building Industry Professional, or</li> <li>• Development with an estimated cost of \$1,000,001 or greater – a Quantity Surveyors Report or Cost Summary Report completed by a Quantity Surveyor</li> </ul> <p><a href="#">Cost Summary Report/Quantity Surveyors Report Form</a></p>   |
| <b>All Plans - General note</b>   | <p>All plans are to clearly highlight the proposed works. Buildings or parts of buildings to be demolished are to be indicated using a dotted line or are to be shown on a separate plan.</p> <p>Plans must be to scale (1:100 or 1:200) with the scale clearly identified on each plan. The following information should be included/shown on all plans and documents:</p> <ul style="list-style-type: none"> <li>• Applicant(s) name(s),</li> <li>• property address (block/house/shop/flat number),</li> <li>• lot number, section number and Deposited Plan / Strata Plan number,</li> <li>• measurements in metric,</li> <li>• draftsman/architect name,</li> <li>• plan/document reference details (date, plan/document name and number, plan version/revision etc.).</li> </ul> <p>All plans/documents must be consistent with any other plan/document presented as part of your application.</p> <p>For food premises, the plans must show details in accordance with the relevant Australian Standards (including AS 4674).</p> <p>For skin penetration premises, the plans must show details in accordance with the Public Health Act.</p>  |
| <b>Site Plan</b>  | <p>A site plan must be submitted with all applications, and is to include (where relevant):</p> <ul style="list-style-type: none"> <li>• boundary locations and all site measurements (length, width and area, both existing and proposed),</li> <li>• dimensioned distances of the new and existing works in relation to site boundaries,</li> <li>• any minimum setbacks/building lines (shown dotted/dashed) as prescribed by the relevant plan or policy,</li> <li>• location and levels of all buildings/structures on adjoining land (including any openings or decks/balconies facing the site),</li> <li>• location and dimensions of all existing and/or proposed impervious areas/hard surfaces (including driveways, decks, paved areas etc.),</li> <li>• location of any existing or proposed swimming pool,</li> <li>• location of any existing and/or proposed fences and landscaping features (including retaining walls, paths etc.),</li> <li>• vegetation and natural features (including canopy trees, rock outcrops etc.),</li> <li>• location and capacity of any existing and/or proposed rainwater tanks,</li> <li>• location of existing and/or proposed car parking, pedestrian and vehicle access (indicating gradients),</li> <li>• location of existing and/or proposed stormwater infrastructure and/or easements (Council and private), both within the site and the adjacent road reserve,</li> <li>• location of all existing and/or proposed utilities, including any associated easements, both within the site and the adjacent road reserve,</li> <li>• location of any utility manholes and power poles, street trees, driveway crossovers and bus stops in the adjacent road reserve,</li> <li>• location of any existing and/or proposed flue/chimney/exhaust and dimensioned distance from the nearest openings of adjoining buildings,</li> <li>• any heritage and archaeological features,</li> <li>• contours at 1m intervals,</li> <li>• north point (true north),</li> <li>• width of road reserve.</li> </ul> |
| <b>Floor Plans</b>  | <p>A floor plan must be submitted with all applications involving internal works, and is to include (where relevant):</p> <ul style="list-style-type: none"> <li>• boundary locations and all site measurements,</li> <li>• dimensioned distances of the new works in relation to site boundaries,</li> <li>• any minimum setbacks/building lines (shown dotted) as prescribed by the relevant plan or policy,</li> <li>• location and levels of all buildings/structures on adjoining land (including any openings or decks/balconies facing the site),</li> <li>• floor levels and steps in floor levels (RLs)(metres AHD),</li> <li>• proposed room names, areas and dimensions,</li> <li>• locations and size of windows and doors,</li> <li>• wall structure type and thickness,</li> <li>• location of plumbing fixtures,</li> <li>• access arrangements and facilities for persons with a disability,</li> <li>• existing floor plan, room names and use (if relevant),</li> <li>• location of any solid fuel heater.</li> </ul>   |

| <b>Elevations and Section Plans</b>  | <p>Sections and elevations must be submitted with all applications that involve physical works and are to include (where relevant):</p> <ul style="list-style-type: none"> <li>• proposed levels (RLs) (metres AHD) for all ridge lines, ceilings, floors and ground,</li> <li>• existing ground levels, including street levels (metres AHD),</li> <li>• outline of existing buildings/development on site (shown dotted),</li> <li>• the maximum applicable building height,</li> <li>• the side boundary building envelope (on elevations),</li> <li>• window size and location,</li> <li>• any chimneys, flues, exhausts etc., including levels (RLs)(metres AHD) at their highest point,</li> <li>• location of all buildings/structures on adjoining land,</li> <li>• roof pitch and eave width,</li> <li>• materials and finishes,</li> <li>• room names/uses (sections only).</li> </ul> <p>Where driveways or other alterations are proposed to Council's infrastructure, detailed sections of gradients and levels must be provided for assessment purposes. | <b>Site Analysis Plan</b>            | <p>A context and site analysis plan must accompany all applications, demonstrating that consideration has been given to site constraints and the context of the immediate locality, including (but not limited to):</p> <ul style="list-style-type: none"> <li>• views to and from the site,</li> <li>• solar access and overshadowing,</li> <li>• views and solar access enjoyed by adjacent properties,</li> <li>• adjoining and nearby land uses,</li> <li>• orientation, microclimate and noise sources,</li> <li>• significant vegetation.</li> </ul>   |
| <b>Demolition Plan</b>               | <p>A demolition plan must be submitted with all applications involving demolition and is to clearly identify all structures to be demolished.</p>  |
| <b>Excavation and / or fill Plan</b> | <p>A plan showing the extent and volume of excavation and / or fill must be submitted for all developments involving excavation and fill, except where the excavation is only for the provisions of foundations.</p>   |

| <b>Waste Management Plan Construction, Demolition and/or ongoing</b> | <p>A Waste Management Plan and a Waste Management Site Plan must be submitted with all developments involving demolition, earthworks or construction. The Waste Management Plan must be filled out in accordance with the Northern Beaches Waste Management Guidelines and must detail the reuse, recycling and disposal methods for all demolition and construction waste on site.</p> <p>The Waste Management Site Plan must show the locations of waste storage, demolition site access, sorting areas, skip bins required and other details for how waste on the site will be managed during the demolition and construction phases.</p> <p>Additional requirements apply if the land is in MLEP 2013, being:</p> <p>Council may request that either the whole or part of the Waste Management Plan be submitted at DA stage where:</p> <ul style="list-style-type: none"> <li>• development is located in the Manly Town Centre,</li> <li>• development includes more than 40 dwelling units, or where</li> <li>• the property does not have reasonable access to Council's usual garbage and recycling collection point.</li> </ul> <p>During demolition and construction, residues from operations such as masonry-cutting, washing tools, and concreting must be:</p> <ul style="list-style-type: none"> <li>• contained on the site and treated using sedimentation settling tanks or flocculation and disposed of in accordance with the Waste Management Plan at paragraph 2.1.12</li> <li>• stored well clear of any poorly drained or flood prone areas, stream banks, and channel or stormwater drainage area in a designated area and under cover where possible, and</li> <li>• provided with containment bunds, constructed around the storage areas which allow salvaging of spilt materials.</li> </ul> <p>A Waste Management Plan must be submitted with all development applications involving multi-unit residential (i.e. more than two residential units or dwellings), all commercial and all industrial developments.</p> <p><b>PLEP 2014</b></p> <p>The Waste Management Plan must be filled out in accordance with the Northern Beaches Waste Management Guidelines.</p> <p>In addition, all relevant plans submitted with the application (e.g.: floor plans, sections and site plans) must show details to identify location of waste storage areas (garbage and recycling), location of collection area, number of bins and hours of collection.</p> <p><b>WLEP 2011</b></p> <p>The Waste Management Plan must be filled out in accordance with the Northern Beaches Waste Management Guidelines and Parts C8 &amp; C9 of the Warringah DCP 2011.</p> <p>In addition, all relevant plans submitted with the application (e.g.: floor plans, sections and site plans) must show details to identify location of waste storage areas (garbage and recycling), location of collection area, number of bins and hours of collection.</p> <p><b>MLEP 2013</b></p> <p>A Waste Management Plan must be submitted with all development applications involving residential, commercial and industrial developments.</p> <p>The Waste Management Plan must be filled out in accordance with Section 3.8 of the Manly DCP 2013. Council may request that either the whole or part of the Waste Management Plan be submitted at DA stage where:</p> <ul style="list-style-type: none"> <li>• development is located in the Manly Town Centre,</li> <li>• development includes more than 40 dwelling units, or where</li> <li>• the property does not have reasonable access to Council's usual garbage and recycling collection point.</li> </ul> <p><b>Residential Accommodation</b></p> <p>In relation to dwelling houses, the site plan and floor plan layout of the proposed development must provide for the ongoing management of waste for occupants of the development as follows:</p> <ul style="list-style-type: none"> <li>• location of a waste cupboard waste storage area within the dwelling capable of holding a single day's waste and allow source separation of non-recyclable and recyclable waste,</li> <li>• location of external waste storage and recycling area capable of accommodating Council's standard garbage and recycling bins, located outside the dwelling with convenient access to the usual collection point.</li> </ul> <p>Note: If a development is to include a mix of residential and commercial activities, separate collection arrangements must be provided.</p> <p>In relation to all other residential accommodation involving more than 1 dwelling, the proposed development must provide for the ongoing management of waste for occupants of the development as follows:</p> <ul style="list-style-type: none"> <li>• the location of individual, external waste storage and recycling area(s) relative to the usual collection point, or</li> <li>• if a communal waste storage and recycling area(s) or garbage and recycling room(s) are proposed, design specifications must be included. This would include a floor plan, elevations and cross section drawings of the room and also the materials and finishes to be used, and</li> <li>• design details of any garbage chute if applicable.</li> </ul> |

|   | <p>If a communal facility is proposed, the area(s) must:</p> <ul style="list-style-type: none"> <li>• be able to accommodate all bins required,</li> <li>• be accessible from all dwellings, and</li> <li>• have prominent signage indicating correct use of bins.</li> </ul> <p>The location and design of the waste storage area must complement the streetscape and must not impact on the amenity of adjoining properties (visual, noise, and odour).</p> <p><b>Commercial and Industrial Development</b></p> <p>Commercial and Industrial building works require the following details to be provided on the floor/site plan:</p> <ul style="list-style-type: none"> <li>• individual waste storage and recycling area(s) located externally and relative to the collection point, or</li> <li>• if a communal waste storage and recycling area(s) or garbage and recycling room(s) are proposed, design specifications must be included. This would include a floor plan, elevations and cross section drawings of the room and also materials and finishes,</li> <li>• design details of garbage chute system(s) and any volume reduction equipment.</li> </ul> <p>If individual garbage and recycling storage areas are proposed, sufficient space must be provided to facilitate source separation of waste and must be compatible with the chosen waste collection service.</p> <ul style="list-style-type: none"> <li>• If a communal waste storage and recycling area is proposed the following requirements also apply:</li> <li>• each separately tenanted or separately occupied area within the building or complex must have easy access to collection containers able to accommodate the type and quantity of waste and recyclable material generated,</li> <li>• be able to accommodate all bins required,</li> <li>• have prominent signage indicating correct use of bins, and</li> <li>• garbage and recycling facilities must be situated as to not impact on the amenity of adjoining premises (noise, odour or visual).</li> </ul> <p><b>Note: Where hazardous or unique waste materials are to be generated special arrangements will be required. Advice should be sought from the Environment Protection Authority or Council on the specific management arrangements for these materials.</b></p> |
| <p><b>Certified Shadow Diagrams</b></p> | <p>Shadow diagrams must be submitted for new developments that will result in additional shadow impacts to demonstrate compliance with the requirements in the relevant DCP. Shadow diagrams must take into account the slope of the land.</p> <p>Existing and proposed shadows are to be shown as cast on 21 June at 9am, 12noon and 3pm. The diagrams should include:</p> <ul style="list-style-type: none"> <li>• location of proposed development,</li> <li>• position and relationship to adjoining buildings and land (showing street number and street address),</li> <li>• details of existing and proposed shadows,</li> <li>• diagrams must be based on a Survey plan prepared by a registered Surveyor and drawn to true north,</li> <li>• the shadow diagrams are to be certified by a suitably qualified person such as an Architect,</li> <li>• additional shadow diagrams including hourly shadow diagrams or elevational shadow diagrams may be required.</li> <li>• location of all the boundaries on adjoining land that is effected by any proposed overshadowing</li> </ul> <p>The shadow diagrams must be accompanied by a document prepared by a suitably qualified professional stating that the shadow diagrams have been certified as accurate. Council may require this document to be prepared by an independent professional for larger developments</p>   |
| <p><b>Photo Montage</b></p>             | <p>A photo montage must be submitted for any development where the cost of works exceeds \$5 million or as requested by Council.</p> <p>Photomontages are to show the key contextual streetscape, and neighbourhood settings of the proposed development and other relevant images, such as impacts on critical/sensitive views from both the public (including waterways) and private domains. The montages are to be generated from a Survey and are to be accurate and detailed 3-dimensional computer models of the proposed development.</p>  |
| <p><b>Subdivision Plan</b></p>          | <p>Applications involving the subdivision of land must be accompanied by a draft plan of subdivision demonstrating:</p> <ul style="list-style-type: none"> <li>• proposed lot sizes,</li> <li>• dimensions of all boundaries,</li> <li>• vehicular and pedestrian access to all lots,</li> <li>• any land to be dedicated to Council,</li> <li>• any existing or proposed easements, covenants or right of ways,</li> <li>• location of essential infrastructure servicing all lots.</li> </ul> <p>For undersized allotments and sites that are physically constrained (i.e. small site or small buildable area), indicative building footprints should also be nominated. For these sites it is recommended that you confirm the requirements through a pre lodgement meeting.</p> <p>Applications for Community title subdivision shall also be supported by a draft Community /Neighbourhood Management Statement.</p> <p>Applications involving Strata subdivision shall be accompanied by a draft plan of Strata subdivision demonstrating:</p> <ul style="list-style-type: none"> <li>• proposed lot sizes,</li> <li>• common property,</li> <li>• any easements or restrictions.</li> </ul> <p>Additional requirements for subdivision in the Warriewood Valley Release Area are prescribed by Control C6.9 of P21 DCP.</p>   |

| <b>Road design Plan</b>                  | <p>For applications involving the construction of new roads or upgrades to existing roads, detailed civil engineering plans, long sections and cross sections are required for the full extent of the works.</p> <p>If the proposal is in Warriewood Valley Land Release Area, see the Warriewood Valley Roads Masterplan and Warriewood Valley Landscape Masterplan and Design Guidelines (Public Domain) for additional requirements.</p>  |
| <b>Advertising Structure / Sign Plan</b> | <p>Advertising/signage details must be submitted for all applications that involve advertising or business or building identification signage.</p> <ul style="list-style-type: none"> <li>• details of the advertising structure / sign, materials to be used and how it will be fixed to the building,</li> <li>• dimensions (including width, height and depth), colours, lettering and overall design,</li> <li>• the proposed location shown on the site plan (show distances to boundaries),</li> <li>• details of any existing signage on the property, including dimensions, and details if removal is proposed,</li> <li>• illuminated signage – provide details of illumination including type (e.g. flood light, internally illuminated), hours of illumination, amount and extent of light spill (light spill diagram may be requested),</li> <li>• SEPP 64 Advertising and Signage criteria and DCP requirement are to be addressed.</li> </ul>  |
