This application excludes the construction of retaining walls, stairs and other structures, for these please refer to the <i>Application for works to be approved within Council roadway</i> (if associated with a development application) or the <i>Application for a Minor Encroachment on a Road Reserve form</i> (if not associated with a development application). |

| The construction of a driveway must be undertaken by an Authorised Contractor. A list of contractors authorised by Council is available at northernbeaches.nsw.gov.au If your preferred contractor is not on this list please note that they must become authorised prior to carrying out work. This may delay the processing of your application by approximately 6 weeks. The contractor is required to complete Form #4026 to be assessed for authorisation. |

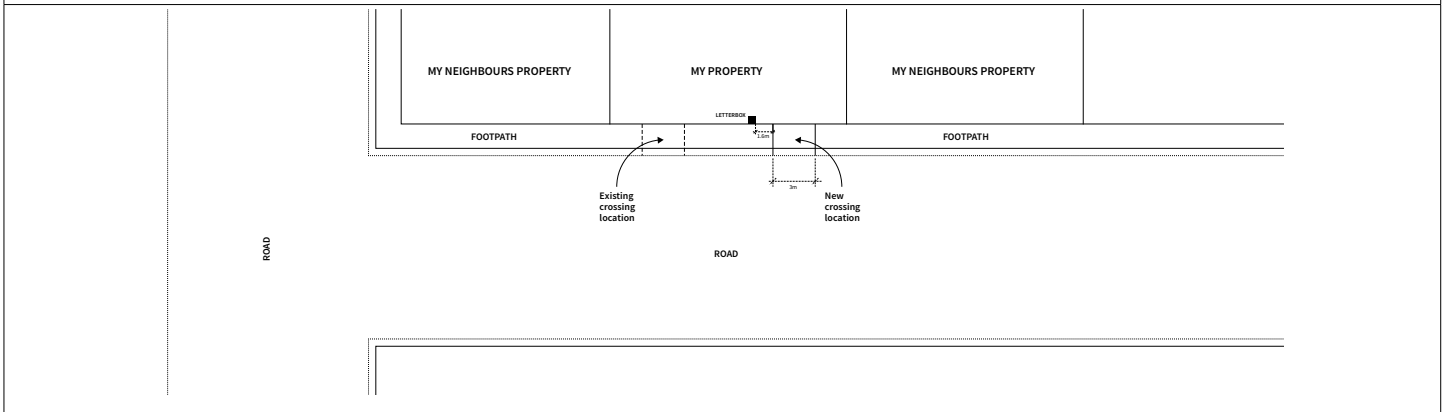
Driveway crossings shall be constructed with plain broom finished concrete, or approved equivalent. All cosmetic/decorative treatments, including but not limited to, asphalt, paved, coloured, exposed aggregate, stamped, stencilled and post construction treatments are prohibited. Failure to comply with this requirement may result in demolition of the crossing and reconstruction of the crossing to Council standard, with all costs borne by the applicant.
