<p>Booking Information and Conditions</p> <ul style="list-style-type: none"> • A sign with your name on it will be placed on your table the day of the booking to reserve the table. • Each application will be assessed individually and an invoice and set of conditions issued. • A booking is for the whole day. Please note that gates at Manly Dam are open from dawn to dusk. Although you may stay at the Dam after the gates are closed all vehicles must be outside the gates prior to them being locked. Please contact Customer Service on 1300 434 434 for specific opening and closing times. • Council accepts no liability or responsibility for loss, damage or accidents that occur on Council's reserves. • All areas must be left in a clean and tidy condition and no damage caused. Should it be necessary to conduct additional cleaning or maintenance as a result of your use, you will be invoiced accordingly. • You are responsible for taking all necessary precautions to ensure the safety of participants. • That no undue inconvenience is caused to other users of the park. • Permission is required for the erection of any tents, marquees and other structures, please contact the Open Space Bookings Team. If approved they are to be positioned so as not to inconvenience or pose any risk to the general public. • Council has provided both electric and wood barbecues in number of areas within the Dam. Only portable above ground gas barbecues may be used other than those provided by Council, however these barbecues may only be used in the designated barbecue areas. This consent is subject to current fire restrictions, please refer to www.rfs.nsw.gov.au for up to date fire restriction information. • Council's Pay and Display parking system will be in operation during your event and vehicles should be confined to designated parking areas only. No parking fees apply to Northern Beaches Parking Permit holders. • All noise and especially any amplification systems being maintained of a character which is not 'offensive' as defined by the Protection of the Environment Operations Act 1997. • Dog are prohibited in the picnic areas at Manly Dam. • Payment must be made prior to the event date.
