<p><b>Council supports and recognises the value that car share schemes provide through reduced private vehicle ownership and less demand for on-street parking.</b></p> <p><b>Registered car share providers may be eligible for precinct parking permits for use with car share vehicles in designated areas.</b></p> <p><b>The vehicle must be registered in the name of the business or the business proprietor, registered in NSW or classified as a vehicle temporarily in NSW under clause 9 of Schedule 1 of the Road Transport (Vehicle Registration) Regulation.</b></p>
<p><b>Requirements</b></p> <p>The vehicle must be registered in the name of the car share company:</p> <ol style="list-style-type: none"> <li>1. Provide a valid business registration certificate and ABN</li> <li>2. Provide a current RMS registration certificate showing receipt of payment of registration</li> </ol> <p>Vehicles must not exceed 4.5 tonnes gross vehicle mass or greater than 7.5m in length or be a truck, boat, bus, caravan, campervan, trailer (all) or tractor.</p> <p><i>Please note:</i></p> <p><i>Vehicle registration number will be printed on the permit</i></p> <p><i>Council may include restrictions to the time &amp; date that the permit can be used based on the operation requirements of the business</i></p> <p><i>Permit must be affixed to the vehicle windscreen as per the terms &amp; conditions</i></p> <p><i>Permit does not guarantee a parking space within a scheme area and not does provide exemptions from other parking restrictions or laws such as bus zones, loading zones etc.</i></p>

- Vehicles exceeding 4.5 tonnes gross mass or be greater than 7.5 metres in length
- Vehicles classified as a truck, boat, bus, caravan, campervan, trailer (all types) or tractor
- A household which occupies a dwelling with was approved with the condition that no parking permits be issued
- A household that has a second dwelling that has not been subdivided and for which parking permits are already issued
- A dwelling not approved for residential use
