As condition of borrowing a Northern Beaches Council's Cage Trap the operator must: <ul style="list-style-type: none"> <li>Abide by the Prevention of Cruelty to Animals Act 1997, including: placing the cage in a sheltered position, checking the cage twice per day, providing food and water and taking the animal to the vet at the earliest possible time following capture.</li> <li>Complete Northern Beaches Council's Trapping Monitoring Sheet for the duration of the trapping process, to be returned with the trap at the end of the program. Bond will only be paid if monitoring sheet is returned and completed.</li> <li>Return trap to Northern Beaches Council in a clean and good condition after use.</li> <li>Not use the trap for the capture of native animals.</li> <li>If a cat is seized in accordance with section 32 of the Companion Animals Act 1998 report to Council in order for steps to be taken to identify the owner of the cat or for an Authorised Officer to issue a direction to take the cat to the pound.</li> <li>Operate the cage trap in accordance with the operating guide. Council will not accept responsibility for injuries associated with using the cage trap.</li> </ul>
